

**WATERLOO AMATEUR RETRIEVER CLUB
LIABILITY RELEASE AND INDEMNITY AGREEMENT**

I hereby acknowledge that I have read and understand and agree to comply with the provisions of this document relating to certain activities, including but not limited to dog training, on any property leased or gained access to by the Waterloo Amateur Retriever Club ("WARC"), regardless of the location where such activities are held, whether formally or informally organized by WARC or by any of its individual members. This document relates to any property leased by WARC, or which WARC has gained access to without a written lease, including certain property in Williamson County, Travis County, Lee County and Bastrop County, Texas.

I further acknowledge that no warranties, either expressed, implied or otherwise have been made to me by WARC, its members, officers, employees and/or agents or by the owner and/or lessor of any property leased or gained access to by WARC regarding the condition of the property, or any improvements thereon, or suitability for any specific purpose. I understand that while on any such property that I, my spouse, my children, my guests, my dogs and my property may be exposed to dangerous conditions, risks and hazards which could lead to person injury, loss of property and death. I hereby acknowledge that I have been warned of the various dangers which might exist and I hereby assume the risks and responsibility of the various known and unknown dangers, risks and hazards that I may be exposed to including but not limited to: poisonous snakes, insects, erosion and general conditions of the property both on and off the roadways, possible hazardous walking and driving conditions, dangerous or diseased animals both wild and domestic, dangerous water and hidden hazards within, persons with firearms both on and off of the property, dog training equipment, electric fences, barbed wire fences and other miscellaneous dangers both known and unknown.

In consideration of the right to enter and use any property leased or gained access to by WARC for dog training or any other activities, regardless of the location where such activities are held, whether formally or informally organized by WARC or by any of its individual members, I hereby unconditionally release WARC, the owner and/or lessor of any property leased or gained access to, their agents, employees, members, officers, successors and assigns from all claims, demands, causes of action, and damages including attorney fees which may be made or brought by myself, my spouse, my guest and/or my children against any of the parties released herein. I understand that this release includes but is not limited to any claims, causes of action, demands or damages which are caused or are alleged to have been caused by the negligence, gross negligence, strict liability or other acts of the parties released herein.

I further agree to protect, indemnify and hold harmless WARC, the owner and/or lessor of the property leased or gained access to, their agents, employees, members, officers, successors and assigns from all claims, demands, causes of action, and damages including attorney fees which may be made or brought by myself, my spouse, my guest and/or my children against any of the parties released herein.

I agree that any claims, actions or proceedings against the parties released herein shall be litigated in Williamson County, Texas. Furthermore I submit to the jurisdiction of the local state court in Williamson County, Texas. I further waive objection I may have to any suit in Williamson County, Texas.

I acknowledge that I have read and understand the terms and conditions of this agreement and I unconditionally and voluntarily accept same in consideration of my right to enter any property leased or gained access to by WARC for dog training or any other activities, regardless of the location where such activities are held, whether formally or informally organized by WARC or by any of its individual members.

The invalidity of one or more of the provisions of this agreement will not invalidate any of its other provisions.
